## RESOLUTION NO. 3342, S-2023

A RESOLUTION DECLARING THE MANDALUYONG CITY MEDICAL CENTER (MCMC) LOCATED AT C3 ROAD, BARANGAY ADDITION HILLS, MANDALUYONG CITY, AS THE MCMC COMPOUND FOR THE CONSTRUCTION OF ADDITIONAL FACILITIES

WHEREAS, the Mandaluyong City Medical Center (MCMC) is a government hospital duly organized and existing in accordance with the laws of the Republic of the Philippines, duly represented by Dr. Cesar Tutaan, its Medical Director;

WHEREAS, MCMC is a PhilHealth-accredited/DOH-licensed Secondary Level Government Health Facility which has the services, medical doctors, and personnel capable to provide medical and hospitalization to its patients;

WHEREAS, the 4Ps party-list, through Cong. Jonathan Clement "JC" M. Abalos II, pledged funds to cover the construction of additional facilities in MCMC, including a Diagnostic and Imaging Facility;

WHEREAS, the DOH and DPWH require an enabling act or resolution as part of its requirements for the construction of a Diagnostic and Imaging Facility:

WHEREAS, the City Planning & Development Department has submitted the proposed site development plan of the MCMC Compound, which includes the proposed Diagnostic and Imaging Facility as well as a proposed 3-storey parking building;

WHEREAS, the proposed project will be conducted in accordance with the existing procurement rules and other relevant laws of the Republic of the Philippines;

WHEREAS, the completion of the proposed project will redound to the best interest of the constituents of the City of Mandaluyong.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to declare the complex of Mandaluyong City Medical Center (MCMC) located at C3 Road, Barangay Addition Hills, Mandaluyong City, as an entire compound, for the construction of additional facilities.

This Resolution shall take effect immediately upon its approval.
