**RESOLUTION NO. 3345, S-2023**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE PAYMENT COLLECTION SERVICE AGREEMENT AND OTHER ANCILLARY AGREEMENTS WITH THE CIS BAYAD CENTER, INC. (CBCI)**

WHEREAS, the City Government of Mandaluyong is continuously undertaking the modernization of its facility to provide fast and efficient alternative payment collection services to its constituents;

WHEREAS, in compliance with Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, the City Government aims to establish effective practices and efficient turnaround of the delivery of government services through business one-stop-shops for business and license permit application and renewal, construction permits, tax payments, as well as to provide easy and accessible payment options to its constituents;

WHEREAS, the City Government intends to bring about more efficient and effective payment and collection services for transacting constituents through an electronic payment and collection system allowing the government to better manage the financial resources and improving revenue generation capability;

WHEREAS, CIS Bayad Center, Inc. (CBCI) offers payment collection services to the City Government to help achieve the foregoing purpose;

WHEREAS, there is a need to authorize the Honorable City Mayor to execute and sign the Payment Collection Service Agreement and other ancillary agreements with CBCI for the latter to render the service;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Payment Collection Service Agreement and related agreements that will govern the parties' complementary rights and obligations, and the same have been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Payment Collection Service Agreement and other ancillary agreements with CIS Bayad Center, Inc. (CBCI).

FURTHER, RESOLVED, as it hereby RESOLVES, that copy of this Resolution be furnished to the Office of the City Mayor, City Treasurer's Department, City Accounting Department, City Information and Communication Technology Department and CIS Bayad Center, Inc. (CBCI) for their information and appropriate action.
