UNIVERSITY (RTU), THRU ITS EXTENSION AND  
COMMUNITY SERVICES CENTER (ECSC), FOR THE  
CONDUCT OF THE LATTER'S EXTENSION OF  
ENTREPRENEURIAL COMMUNITY PROGRAMS,  
SERVICES AND DEVELOPMENT TRAINING  
WORKSHOPS**

WHEREAS, Rizal Technological University (RTU) is one of the renowned state universities of the Philippines that is based in Mandaluyong City and delivers quality and affordable education to the youth and professionals, through its instruction, research and extension services;

WHEREAS, Rizal Technological University (RTU) is a higher education institute mandated to provide highly educational, professional, scientific and special instructions in engineering and technology, education, sports, business, entrepreneurial technology and the arts and science;

WHEREAS, RTU, through its Extension & Community Services Center (ECSC), wishes to channel their expertise and expand the scope of its extension services with the City of Mandaluyong through the Tiger City Negosyo Center;

WHEREAS, RTU-ECSC's extension services will involve series of lecture-training workshops on entrepreneurial programs development, and it will be extended to the City Government of Mandaluyong as Partner Agency, free of charge, though assistance is sought as to added logistics and equipment upon availability;

WHEREAS, the Tiger City Negosyo Center has expressed the need for RTU-ECSC's assistance in the development and implementation of sustainable and impactful extension programs in the community;

WHEREAS, taking into consideration the entrepreneurial programs of the City Government of Mandaluyong, the extension services offered for free by RTU-Extension & Community Services Center (ECSC) will greatly benefit the constituents of the City to enhance their entrepreneurial skills and knowledge;


WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that defines the complementary obligations of the parties, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it is hereby RESOLVED to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign a Memorandum of Agreement with the Rizal Technological University (RTU) through its Extension & Community Services Center (ECSC) for the conduct of the latter's extension of entrepreneurial community programs, services and development training workshops to the City Government of Mandaluyong.


