RESOLUTION NO. 3352, S-2023

**A RESOLUTION ADOPTING AND
APPROVING THE CITY NUTRITION
ACTION PLAN FOR 2023-2025 OF THE
CITY OF MANDALUYONG**

WHEREAS, maternal and child malnutrition continue to be of alarming levels in the Philippines as indicated in the National Nutrition Survey conducted by the Food and Nutrition Research Institute - Department of Science and Technology (FNRI-DOST);

WHEREAS, the nutrition profile of the City of Mandaluyong, based on the results of Operation Timbang plus (OPT Plus), shows that stunting and wasting among under five-year-old children and other forms of malnutrition in the City of Mandaluyong remain to be public health concerns;

WHEREAS, based on the 2023 OPT Plus result, a total of 88 or 0.24% of under-five children were found to be stunted (bansot), 94 or 0.26% were wasted or thin and 87 or 0.24% were overweight and obese;

WHEREAS, micronutrient deficiencies, maternal malnutrition, and rising cases of teenage pregnancies and learning are among the nutrition challenges in the City of Mandaluyong;

WHEREAS, these serious cases of malnutrition have negative impact on the overall health and development and learning potentials of children in later years and lead to less productive lives as adults, and affect their ability to ensure the overall well-being of future families in the City of Mandaluyong;

WHEREAS, investing in nutrition, in general, is indeed cost-efficient, and more so is investing in the critical period of first 1000 days of life which covers the period from pregnancy on the second birthday of a child. It is a unique period of opportunity when the foundations of optimum growth and development as well as lifelong health are established;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) is the country's framework in addressing stunting, wasting, and other forms of malnutrition and is integral of the Philippines Development Plan (PDP) and Ambisyon Natin 2040;

WHEREAS, the PPAN is translated to the Local Nutrition Action Plan (LNAP) at the provincial, city, municipal, and barangay levels to respond to the local nutrition challenges and problems while adapting the PPAN-based programs, projects, and activities to contribute to national outcome targets and goals;

WHEREAS, the LNAP is prepared by the local nutrition committee and is integral part of the local development plan and annual investment program;

WHEREAS, the LNAP is a three-year plan that contains (a) an assessment of the local nutrition and related situation, (b) the objectives for the nutrition programs, (c) a work plan to implement Programs, projects, and activities, (d) a monitoring and evaluation scheme, (e) an estimate budgetary requirement, and (f) arrangement for organization and coordination;

WHEREAS, the City of Mandaluyong formulated the local Nutrition Action Plan for 2023-2025 as a response to the nutrition problems identified by the LNC and is consistent with the Philippine Plan of Action for Nutrition 2023-2023, the Regional Plan of Action for Nutrition of the National Capital Region and is aligned with the over-all vision of the City of Mandaluyong.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it is hereby RESOLVED to adopt and approve the City Nutrition Action Plan for 2023-2025 of the City of Mandaluyong.

RESOLVED FURTHER, that members of the City of Mandaluyong Nutrition Committee commit to pursue the programs and projects in the LNAP, ensure availability of resources, including related budgetary requirements and submit physical and financial accomplishments;


RESOLVED FURTHERMORE, for the City of Mandaluyong Nutrition Office to ensure that plan is integrated in the Comprehensive Development Plan and Annual Investment Program of the City of Mandaluyong and to disseminate the LNAP as widely as possible to enable stakeholders to align their efforts along the priority concerns;

RESOLVED FURTHER, for the City Nutrition Office being the LNC Secretariat to:

1. Coordinate with relevant units of the City Government to facilitate the formulation of annual operational plans thereafter;
2. Coordinate and monitor the implementation of this Resolution;
3. Submit a copy of this Resolution to the National Nutrition Council-NCR;


