**RESOLUTION NO. 3363, S-2023**



A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS, REPRESENTING THE CITY GOVERNMENT OF MANDALUYONG, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE CITY MAYOR FRANCISCO M. ZAMORA REPRESENTING THE CITY GOVERNMENT OF SAN JUAN, FOR THE SECONDMENT OF A LICENSED REAL ESTATE APPRAISER TO COMPLEMENT THE TECHNICAL STAFF OF THE SAN JUAN CITY ASSESSMENT DEPARTMENT

WHEREAS, the City Assessor and the Assistant City Assessor positions of the City Government of San Juan City remain vacant and they have no licensed Real Estate Appraiser to conduct a general revision of real properties;

WHEREAS, in a letter dated October 12, 2023, the City Government of San Juan, thru City Mayor Francisco M. Zamora, requested from Mandaluyong City Mayor Benjamin S. Abalos for the secondment of a licensed real estate appraiser to complement the technical staff of the San Juan City Assessment Department;

WHEREAS, the Administrative Code of 1987 allows the SECONDMENT of government employees to a RECEIVING AGENCY who desires to engage the services of qualified technical personnel to assist the RECEIVING AGENCY's department;

WHEREAS, in the interest of service, the City Government of Mandaluyong is willing to grant the request of the City Government of San Juan, through SECONDMENT of MR. ERWIN G. NAVARRO, a LOCAL ASSESSMENT OPERATIONS OFFICER (LAOO), who has a Real Estate Service Eligibility, for a period of one (1) year;

WHEREAS, the Civil Service Commission (CSC), through Resolution No. 061165, provides for the rules on inter-department secondment, necessitating the execution of a Memorandum of Agreement, as concurred in by the employee;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with the law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod ng Mandaluyong, in session assembled, RESOLVED as it hereby RESOLVES to authorize the Honorable City Mayor Benjamin S. Abalos, representing the City Government of Mandaluyong, to enter into a Memorandum of Agreement with the Honorable City Mayor Francisco M. Zamora, representing the City Government of San Juan, for the secondment of MR. ERWIN G. NAVARRO, a licensed Real Estate Appraiser, to complement the technical staff of the San Juan City Assessment Department.
