A RESOLUTION EXTOLLING AND REMEMBERING THE GOOD DEEDS OF THE LATE FAUSTINO "JOJO" O. CRUZ, JR., FORMER BARANGAY CHAIRMAN OF BARANGKA IBABA, MANDALUYONG CITY WHO DIED LAST JANUARY 24, 2024

WHEREAS, Faustino O. Cruz, Jr. was born on December 13, 1969, to the late Sps. Faustino Cruz Sr. and Emilia Oladive and he is 6th in a brood of 8;

WHEREAS the late Faustino O. Cruz, Jr. graduated with the degree of Bachelor of Science in Civil Engineering at the Manuel L. Quezon University in 1993 and Bachelor of Science in Sanitary Engineering at the National University in 1994. He worked as a Project Engineer in several private companies like the J.C. Rodriguez Construction Corporation, Diversion Industries, Inc. and M2 Fashion from 1992 to March 2012 before joining Barangay Barangka Ibaba Council as Kagawad from May 2010 to November 2013;

WHEREAS, the late Faustino O. Cruz, Jr. was elected Barangay Captain of Barangka Ibaba and he served his constituents from December 2013 to June 30, 2018; he has been very active in public service and has made himself dedicatedly involved in every social and developmental works in his own barangay.

WHEREAS, in 2019 until June 2022, the late Faustino O. Cruz, Jr. headed the MADAC Rehab and Aftercare Division of the Mandaluyong Anti-Drug Abuse Council; and in July 2022 up to December, 2022 he served as Presidential Staff Officer III in the Office of the Executive Secretary, Office of the President;

WHEREAS, Kap Jojo's effort and accomplishments are worthy to be remembered and recorded in the books of Barangay Barangka Ibaba Council which undoubtedly contributed to the progress of said Barangay;

WHEREAS, the late Barangay Chairman Faustino O. Cruz, Jr. fondly called JOJO, among peers, associates and the grassroots is a great loss to the people of Barangay Barangka Ibaba and of the City where he served with sincerity, dignity and probity;

WHEREAS, the citizens of Mandaluyong would surely miss the amiable Barangay Captain of Barangka Ibaba for he is a simple, friendly and happy Barangay official and such loss is enshrined in the heart of the Mandaleños;

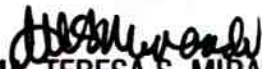

ADOPTED on this 29th day of January 2024, in the City of Mandaluyong.

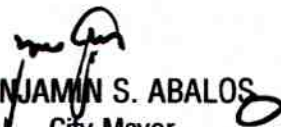
