RESOLUTION NO. 3408, S-2024

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE BENJAMIN S. ABALOS, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY — NATIONAL CAPITAL REGION OFFICE FOR THE RENEWAL OF PARTNERSHIP RELATIVE TO THE OPERATIONS OF THE MANDALUYONG NEGOSYO CENTER

WHEREAS, Republic Act No. 10644 otherwise known as the "Go Negosyo Act' seeks to strengthen micro, small and medium enterprises to create more job opportunities in the country;

WHEREAS, pursuant to this, the DTI-NCR and the City Government of Mandaluyong entered into a Memorandum of Agreement (MOA) for the establishment and operation of the Tiger City Negosyo Center on September 28, 2015;

WHEREAS, the Parties desire to formally renew and reestablish their continuing partnership in the management and operations of the Tiger City Negosyo Center by entering into a subsequent MOA;

WHEREAS, Sections 22(a)(5) and (c) of the Local Government Code of 1991 provides that local government units have the power to enter into contracts with other entities and these contracts can be in the form of a Memorandum of Agreement (MOA);

WHEREAS, Section 22(c) of the LGC, likewise, provides that such power to enter into a contract can be exercised by the LGU concerned through its local chief executive (LCE) provided that said official has been duly authorized by the Sanggunian concerned.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City Mayor, Honorable Benjamin S. Abalos, to enter into and sign the MOA with DTI-NCR regarding their continuous partnership in the operation and maintenance of the Tiger City Negosyo Center.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, Department of Trade and Industry – National Capital Region and all other departments and offices of the City for their information and guidance.
