RESOLUTION EXPRESSING SINCEREST APPRECIATION AND GRATITUDE TO THE LATE SENATE PRESIDENT NEPTALI A. GONZALES FOR HIS INVALUABLE EFFORT AND SIGNIFICANT CONTRIBUTION IN THE DEVELOPMENT AND PROGRESS OF THE CITY OF MANDALUYONG EVIDENCED BY THE URBANIZATION AND CITYHOOD OF MANDALUYONG

WHEREAS, the Sangguniang Panlungsod, as the legislative body of the City, has the power to enact Ordinances, approve Resolutions and appropriate funds for the general welfare of the City and its inhabitants, as well as for an efficient and effective City Government;

WHEREAS, this year, the City of Mandaluyong, dubbed as Tiger City, celebrates its 79th Liberation Day as well as the 30th anniversary of its Cityhood;

WHEREAS, in the course of the celebrations, the City Government would like to recognize the Cityhood heroes who made their respective invaluable contributions to the City's development and progress and considered as one of the top-performing highly urbanized progressive cities;

WHEREAS, the late HONORABLE NEPTALI A. GONZALES, a three-time Senate President and hailed many times as one of the Outstanding Legislators of the Philippines is a brilliant statesman whose intellect and compassion for the underprivileged guided him to author laws that will benefit Philippine society and advancing the general welfare of all Mandaleños was one of his guiding lights;

WHEREAS, through his solid leadership and judicial aptitude, the conversion from Municipality to a Highly Urbanized City of Mandaluyong was realized by virtue of Republic Act 7675 enacted on February 9, 1994. This transition brought improved infrastructures, better access to services, and specialized governance structures contributing to overall development and a higher quality of life of Mandaleños emboldened by various economic expansion and investments;
