## RESOLUTION NO. 3413, S-2024

A RESOLUTION RECOGNIZING AND COMMENDING THE VALUABLE INITIATIVES OF HONORABLE CONGRESSMAN RONALDO "RONNY" BAYAN ZAMORA IN THE ESTABLISHMENT OF THE IDENTITY OF THE CITY OF MANDALUYONG AS INSTRUMENT OF ITS STEADFAST AND SUSTAINABLE PROGRESS AND DEVELOPMENT

WHEREAS, the Sangguniang Panlungsod, as the legislative body of the City, has the power to enact ordinances, approve resolutions, and appropriate funds for the general welfare of the City and its inhabitants, as well as for an efficient and effective City Government;

WHEREAS, the Year 2024 marks the 30th Cityhood Anniversary and 79th Liberation Day of the City of Mandaluyong, the attainment of the same being owed to the forefathers of the City who, in a variety of ways, have helped the City achieve and realize its current status as a flourishing City in Metro Manila;

WHEREAS, the City of Mandaluyong originally comprised the congressional district of San Juan-Mandaluyong, as represented by one (1) elected representative and regarded as one (1) legislative and territorial district;

WHEREAS, on 09 February 1994, Republic Act No. 7675, the law distinguishing the City of Mandaluyong as a lone Highly-Urbanized City, was enacted, which was introduced and sponsored by the congressional district's representative, HONORABLE CONGRESSMAN RONALDO "RONNY" BAYAN ZAMORA, eventually leading to the sought-after independence and cityhood of the municipality of Mandaluyong;

WHEREAS, through Honorable Congressman Zamora, the tedious process of the enactment of Republic Act No. 7675 proved to be surmountable, with his expertise, fervent participation, and sponsorship being valuable ingredients to the eventual passage of his sponsored bill and enactment of the law;

WHEREAS, along with his monumental contribution to the City of Mandaluyong, Honorable Congressman Zamora has, likewise, been perpetually regarded as an established symbol of public service and an advocate of good governance, as he served the Filipino people tirelessly to advance their voices and visions with genuine passion and mighty aspirations;

WHEREAS, Honorable Congressman Zamora has also been proven to be a monumental figure in the partnership of the cities of Mandaluyong and San Juan as neighboring cities in Metro Manila, as he steered both localities towards a symbiotic political relationship which proved to have benefitted both in terms of economic growth and prosperity;

WHEREAS, it is undeniable that the efforts initiated and contributions advanced by Honorable Congressman Zamora to the City of Mandaluyong deserve to be acknowledged and recognized;

WHEREAS, the City of Mandaluyong would not be regarded as the Tiger City and would not have cemented its status as a booming locality if not for the initiative of Honorable Congressman Zamora, thus, the Sangguniang Panlungsod's intent to take the 30th Cityhood Anniversary and 79th Liberation Day as an opportunity to express its sincerest gratitude and appreciation to one of the City's pillars of development.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to extend commendation and sincerest appreciation and gratitude to HONORABLE CONGRESSMAN RONALDO "RONNY" BAYAN ZAMORA for his invaluable contribution in the independence, development, and progress of the City of Mandaluyong.

RESOLVED FINALLY, let a copy of this Resolution be furnished to HONORABLE CONGRESSMAN RONALDO "RONNY" BAYAN ZAMORA for his information and memoirs.
