RESOLUTION NO. 3417, S-2024

**RESOLUTION APPROVING AND ADOPTING THE
LOCAL CLIMATE CHANGE ACTION PLAN
(LCCAP) 2023-2032 OF THE CITY OF
MANDALUYONG**

WHEREAS, Global Climate Change, a key development issue for both the present and future, has severe consequences, with majority of human and economic impacts occurring in the development countries. The Philippines, due to its current and future exposure to climate related risks, compounded by rapid degradation of the environment and unsustainable development practices, is highly vulnerable to existing and future climate change related risks;

WHEREAS, under Section 14 of RA 9729 or the Climate Change Act of 2009, the local government units and or the City of Mandaluyong shall be the frontline agencies in the formulation, planning and implementation of climate change action plans in their respective areas, consistent with the provisions of the Local Government Code, the Framework, and the National Climate Change Action Plan;

WHEREAS, the Local Climate Change Action Plan 2023-2032 of the City of Mandaluyong is anchored on the national climate change framework strategy which has been translated into a National Climate Change Action Plan (NCCAP) with various priorities;

WHEREAS, if there is an actual impact of hazards, it is imperative to institutionalize measures, policies, plans and programs of the City Government to ensure resiliency;

WHEREAS, the City of Mandaluyong recognizes the importance of plan implementation and policy enforcement in realizing targets, achieving goals and objectives for the realization of a climate-adaptive and resilient community;

WHEREAS, the implementation of the Local Climate Change Action Plan needs specific measures and instrument. The LCCAP implementation includes the establishment of detailed work systems, and institutional mechanisms that are responsive to the goals and objectives of the LCCAP and the information of partnerships and cooperation arrangement among stakeholders;

WHEREAS, the CDRRMD has facilitated the conduct of CDRA training to the members of the Local Climate Change Core Team and representatives from the 27 barangays last November 13-17 and 20-24, 2023;

WHEREAS, the City Environmental Management Department (CEMD) and the City Disaster Risk Reduction and Management Department (CDRRMD) have presented the proposed LCCAP and content to the DRRMC members of the City of Mandaluyong, which also happens to be the members of the City Climate Change (CCC) Core Team, and approved the same by virtue of Resolution No. 1, Series of 2024 provided that the Climate and Disaster Risk Assessment (CDRA) processes will be incorporated to the same.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to approve and adopt the Local Climate Change Action Plan 2023-2032 of the City of Mandaluyong.

Let copy of this Resolution be furnished the Office of the City Mayor, Office of the City Vice Mayor, Mandaluyong Climate Change Core Team, CDRRMD, DILG Mandaluyong, and all offices concerned for their information, guidance and reference.




