RESOLUTION NO. 3420, S-2024

RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE AMENDED ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR CALENDAR YEAR 2024 TO CHANGE THE PROGRAM/PROJECT/ACTIVITY DESCRIPTION FROM CONSTRUCTION OF PROPOSED LEGISLATIVE BUILDING (14-STOREY WITH DECK) TO CONSTRUCTION OF MULTI-PURPOSE BUILDING IN BARANGAY PLAINVIEW

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the year 2024;

WHEREAS, in the AIP CY 2024, particularly under the Capital Outlay of the City Engineering and Building Officials Department, one of the identified programs/projects/activities is the Construction of Proposed Legislative Building (14-Storey with Deck) in the amount of P1,300,000,000.00;

WHEREAS, on March 20, 2024, the City Government of Mandaluyong was able to secure its initial funding from the Department of the Interior and Local Government (DILG) chargeable against the Local Government Support Fund Financial Assistance to LGUs, FY 2024 General Appropriations Act, Republic Act No. 11975. However, the project was denominated as Construction of Multi-Purpose Building in Barangay Plainview;

WHEREAS, there is a need to amend the description of the project in the AIP CY 2024 to avert any discrepancy and confusion between the records of the City Government and the DILG;

WHEREAS, an amendment to the AIP CY 2024 on Capital Outlay of the City Engineering and Building Officials Department has been prepared for this purpose.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm the Amended Annual Investment Program (AIP) for Calendar Year 2024 of the City Government of Mandaluyong to change the Program/Project/Activity Description from Construction of Proposed Legislative Building (14-Storey with Deck) to Construction of Multi-Purpose Building in Barangay Plainview with approved budget of P1,300,000,000.00.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the Mayor, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.


