RESOLUTION NO. 3441, S-2024

RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR CALENDAR YEAR 2024 TO INCLUDE THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY ENGINEERING AND BUILDING OFFICIALS' DEPARTMENT TO BE FUNDED BY THE 15% OFFICE OF THE BUILDING OFFICIALS (OBO) FUND

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Calendar Year 2024, including the programs, projects and activities (PPA) of the City Engineering and Building Officials Department;

WHEREAS, the Commission on Audit (COA), in Audit Observation Memorandum No. 2024-016 (2023) GF dated March 11, 2024, stated that the OBO has not prepared a Program of Work for the 15% OBO Fund contrary to item 2.6 of DPWH-DILG JMC No. 001, dated July 14, 2013, resulting in the low utilization of the 15% OBO Fund in CY 2023;

WHEREAS, as part of the Management Action, the City Engineering and Building Officials Department was immediately directed to prepare the Program of Work, which was approved by the City Mayor;


WHEREAS, to implement the same, the corresponding Supplemental AIP was prepared to include the PPAs of the City Engineering and Building Officials Department to be funded by the 15% OBO Fund for the consideration and appropriate action by the Sangguniang Panlungsod.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm the Supplemental Annual Investment Program (AIP) of the City Government of Mandaluyong for Calendar Year 2024 to include the programs, projects and activities of the City Engineering and Building Officials Department to be funded by the 15% OBO Fund.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the City Mayor, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.

ADOPTED on this 13th day of May 2024, in the City of Mandaluyong.


