RESOLUTION DESIGNATING THE HONORABLE COUNCILOR BENJAMIN A. ABALOS III AS THE OFFICIAL REPRESENTATIVE AND THE HONORABLE COUNCILOR ANTONIO DLS. SUVA AS ALTERNATE REPRESENTATIVE OF THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB)

WHEREAS, the People's Law Enforcement Board (PLEB) was created by virtue of Republic Act No. 6975 which mandates that there shall be at least one (1) PLEB for every City to hear and decide citizen's complaints or cases filed before it against erring officers and members of the Philippine National Police (PNP);


WHEREAS, one of the composition in the People's Law Enforcement Board (PLEB) is a member of the Sangguniang Panlungsod chosen by the respective Sanggunian; any Barangay Captain of the City chosen by the Association of Barangay Captains and three (3) other members who shall be chosen by the Peace and Order Council from among the respected members of the community known for their probity and integrity;

WHEREAS, the Sangguniang Panlungsod hereby designates the Honorable City Councilor BENJAMIN A. ABALOS III to the People's Law Enforcement Board (PLEB) as its bonafide representative and Honorable Councilor ANTONIO DLS. SUVA as his alternate Representative and shall hold office until replaced or a new representative is appointed.


NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod, in session assembled, RESOLVED, as it hereby RESOLVES, to designate the Honorable Councilor BENJAMIN A. ABALOS III as the official representative and the Honorable Councilor ANTONIO DLS. SUVA as alternate Representative of the Sangguniang Panlungsod of Mandaluyong to the People's Law Enforcement Board (PLEB).
