ADOPTED on this 27<sup>th</sup> day of May 2024, in the City of Mandaluyong.

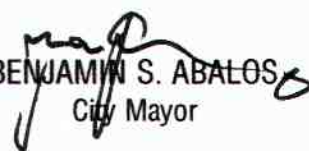
