RESOLUTION NO. 3451, S-2024

A RESOLUTION ADOPTING, CONFIRMING AND RECOGNIZING THE BOOKS ENTITLED "MANDALUYONG 1837-1975 BY PEDRO D. PATRICIO" AND "MANDALUYONG 1470-1950 BY LEONARDO R. VICENCIO" AS THE OFFICAL NARRATIVE HISTORY OF THE CITY OF MANDALUYONG

WHEREAS, Section 15 of Article XIV of the 1987 Constitution provides that "arts and letters shall enjoy the patronage of the State. The State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations";

WHEREAS, Section 2 of Republic Act No. 10066 otherwise known as the "Strengthening People's Nationalism through Philippine History Act" mandates the State to reinforce the importance of national and local history in daily life in achieving social awareness;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" states that "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among others, the preservation and enrichment of culture, xxx";

WHEREAS, the City of Mandaluyong recognizes the importance of cultural education, artistic creation and protection of history and culture through documentation and publication;

WHEREAS, the narrative book of "MANDALUYONG 1837-1975 BY PEDRO D. PATRICIO AND MANDALUYONG 1470-1950 BY LEONARDO R. VICENCIO" is a compilation of historical events and facts of the City, and published by the City Government of Mandaluyong;

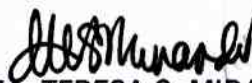

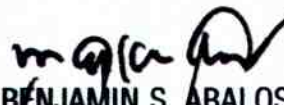
