RESOLUTION NO. 3463, S-2024

**A RESOLUTION RECOMMENDING THAT HONORABLE
CITY MAYOR BENJAMIN S. ABALOS SIGN AND ENTER
INTO A SISTERHOOD AND TWINNING NEGOTIATION
AND AGREEMENT BETWEEN THE PROVINCE OF
SULTAN KUDARAT AND THE CITY OF MANDALUYONG**

WHEREAS, the Province of Sultan Kudarat is situated in the Southwestern Section of Central Mindanao. It is bounded on the north by the provinces of Maguindanao del Norte, Maguindanao del Sur and Cotabato; on the south-by-South Cotabato and Sarangani; on the east by Davao del Sur; and on the west by the Moro Gulf and the Celebes Sea;

WHEREAS, Province of Sultan Kudarat comprises of eleven (11) municipalities and one (1) city. Three of the municipalities (Kalamansig, Lebak, and Palimbang) are coastal towns;

WHEREAS, the population of Sultan Kudarat in the 2020 census was 854,052 people, with a density of 160 inhabitants per square kilometer or 410 inhabitants per square mile;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, establishing a sisterhood partnership between Mandaluyong and Province of Sultan Kudarat would create opportunities for cultural exchange economic development, and goodwill between the two (2) government units;

WHEREAS, the Province of Sultan Kudarat intends to undertake mutually beneficial partnership with the City of Mandaluyong thru its Resolution No. 197, 16th – S.P., Series of 2024 and manifested the province's strong desire to establish a sisterhood-community relation and twinning agreement with the City of Mandaluyong, wherein the sisterhood relation will foster, promote, enhance and formalize a close relationship between the City of Mandaluyong and Province of Sultan Kudarat and also among their constituents;


WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Province of Sultan Kudarat to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood and Twinning Negotiation Agreement between the Province of Sultan Kudarat and the City of Mandaluyong.

Let copy of this Resolution be furnished the Office of the Governor of Province of Sultan Kudarat, Vice Governor and its Council Members for their information and guidance.

ADOPTED on this 26th day of June 2024, in the City of Mandaluyong.


