**RESOLUTION NO. 3472, S-2024**

**A RESOLUTION ADOPTING THE HALINA'T  
MAGTANIM NG PRUTAS AT GULAY  
(HAPAG) SA BARANGAY PROJECT**

WHEREAS, the existing programs by the National Government dedicated to nutrition span across all levels of governance, including the substantial participation of local government units across the country;

WHEREAS, the necessity of addressing food security across the country has been one of the most important concerns that the country face, as challenges has been encountered by the agricultural sector owing to the natural calamities and the COVID-19 pandemic that have rendered produce unutilized and prices of usable ones constantly increasing;

WHEREAS, the role of the Barangays is indispensable in attaining the established plans and programs of the National Government, contributing altogether to the growth and development of the national economy;

WHEREAS, as an indispensable partner of the National Government, barangays have been placed at the forefront of the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project introduced by the Department of the Interior and Local Government;

WHEREAS, the Project seeks to strengthen the capacities of barangays towards sustainable agriculture initiatives, including the promotion of agricultural activities;

WHEREAS, to concretize the involvement of barangays across the country, the establishment of a Barangay Community Garden which aims to diversify the food source and keep the public secure from food shortages and scarcities;

WHEREAS, the City of Mandaluyong and all of its component Barangays are one with the National Government and the DILG in the eventual goal to amplify the security of food across all Filipino households, thus the need for a Council Resolution adopting the relevant rules and guidelines.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to adopt the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project and all its implementing instruments as directed by the Department of the Interior and Local Government.

RESOLVED FURTHER, all Barangays Chairpersons of the City of Mandaluyong are enjoined to implement the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project and all its implementing instruments in their respective areas of jurisdiction, including the establishment of a Barangay Community Garden in accordance with the terms and specifications under DILG Memorandum Circular No. 2023-001;

RESOLVED FURTHER, continuous and consistent implementation, monitoring, and evaluation of the said Project is likewise directed to the appropriate offices of the City Government of Mandaluyong, including the provision of technical and financial assistance to the Barangays in the implementation of agricultural activities and agricultural support services;

RESOLVED FINALLY, that the necessary funding is hereby allotted or appropriated to shoulder the costs or expenses that may be incurred subject to the usual accounting and auditing rules and regulations.
