**RESOLUTION NO. 3477, S-2024**

**RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2024 TO INCLUDE THE CITY STREETLIGHTS PROGRAM OF THE CITY ENGINEERING AND BUILDING OFFICIALS DEPARTMENT**

**BE IT ADOPTED** by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

**WHEREAS**, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Year 2024;

**WHEREAS**, among the detailed programs, projects and activities (PPAs) included in the AIP 2024 pertain to the City Engineering and Building Officials Department;

**WHEREAS**, however, not all PPAs were included as those funded by the Gender and Development (GAD) Fund were not included, particularly, the City Streetlights Program regarding the installation of streetlights and lampposts along Ballesteros Street, Barangay New Zaniga, Mandaluyong City;


**WHEREAS**, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include those PPAs covered by the City Streetlights Program for CY 2024 by the City Engineering and Building Officials Department.
