**RESOLUTION NO. 3478, S-2024**

**A RESOLUTION AUTHORIZING THE CITY OF MANDALUYONG, THROUGH THE LOCAL CHIEF EXECUTIVE TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF A LANDSLIDE INCIDENT WHICH OCCURRED AT BARANGAY BARANGKA ILAYA, MANDALUYONG CITY**

WHEREAS, based on the validated disaster report of the Mandaluyong City Social Welfare and Development Department, in coordination with the City Disaster Risk Reduction and Management Department, a landslide hazard/incident brought about by heavy rains occurred at Barangay Barangka Ilaya, Mandaluyong City;

WHEREAS, based on the City Social Welfare and Development Department report, the landslide hazard/incident yielded five (5) families affected (renters);

WHEREAS, it is the thrust of the City Government of Mandaluyong to provide sincere and efficient public service to its constituents, especially in times of crisis and emergencies, thus, deeming necessary to extend financial assistance to the affected families and structure owners;

WHEREAS, the City Mayor, distraught by this landslide hazard/incident, has initiated to grant financial assistance to the affected family amounting to Five Thousand Pesos (₱5,000.00) per house renter (5 renters). The total amount of Twenty Five Thousand Pesos (₱25,000.00) financial assistance shall be chargeable against the Calamity Fund or Quick Response Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF), subject to accounting and COA auditing laws, rules and regulations;

WHEREAS, said grant of financial assistance to those affected victims merits the consideration of the Sangguniang Panlungsod of Mandaluyong in accordance with the mandated duty of the City to help and promote the welfare of its constituents.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City of Mandaluyong, through the Local Chief Executive, Honorable City Mayor Benjamin S. Abalos, to grant financial assistance to the victims of landslide hazard/incident which occurred at Barangay Barangka Ilaya, Mandaluyong City.

RESOLVED, FINALLY, that copy of this Resolution be furnished the Honorable City Mayor BENJAMIN S. ABALOS at the Office of the City Mayor, and the respective Mandaluyong City Disaster Risk Reduction and Management Department (MCDRRMD) and City Social Welfare and Development Department, for their immediate information and appropriate action.


