WHEREAS, the City of Mandaluyong's Public Employment Service Department has greatly benefited from the dedicated leadership and tireless efforts of its Head, MRS. EMMA LACANLALE JAVIER;

WHEREAS, Mrs. Javier started working as Laborer, Clerk, Administrative Aide, Manpower Development Officer and Labor & Employment Officer from 1976 to 1999 at the Administrator's Office of the City Government of Mandaluyong. She has been the Division Chief of Traffic and Parking Management Office and worked as hearing officer of TPMO's Adjudication Unit, who has dispensed service to people fairly without fear or favor with her adjudicating skills. She also became the Supervising Labor & Employment Officer and Head at Public Employment Service Office (PESO) from 2000 up to present. For almost two (2) decades she has been the face of the PESO-Mandaluyong where she earned the trust and confidence of the PESO Association of Metro Manila (PAMM) year 2016-2019 when she was elected as President and became one of the distinguished members of the Board of Directors of the PESO Managers Association of the Philippines (PESOMAP);

WHEREAS, Mrs. Javier demonstrated unwavering commitment to the mission of PESO, fostering employment opportunities, providing excellent services to job seekers, and contributing significantly to the economic development of the City;

WHEREAS, Mrs. Javier's work ethic, professionalism, innovative approaches and genuine concern for the welfare of others earned respect and admiration of colleagues, clients and broader community, a feat worthy enough to emulate;

WHEREAS, she is one of those who served the longest public service to the City. She played a pivotal role in the successful implementation of numerous employment programs such as Job Fairs, Passport on Wheels, Special Program for Employment of Students (SPES), Jobstart Philippines Program, Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced (TUPAD) workers, OFW Help Desk, skills training initiatives and various projects like business franchise and expo and trade fairs, leaving a lasting impact on the lives of thousands of constituents. Her passion and accomplishments resulted to elevated status of the PESO increasing employment rates in the City by 93% as of year 2022 based on the PSA Annual Labor Force Participation Survey. She is the woman behind the Multi-Awarded PESO-Mandaluyong such as Bayanihan Service Award, DOLE's Choice of the Press and other prestigious awards;

WHEREAS, the sudden passing of Mrs. Javier has brought immense sorrow to her family, colleagues and all who knew her as her absence will be deeply felt;

WHEREAS, it is but fit to honor and extol the life of Mrs. Emma Javier and expresses profound sympathy and sincere condolences to her family on her passing through this Resolution dedicated for her public service rendered that is truly deserved;


