RESOLUTION NO. 3483, S-2024

A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF DONSOL, PROVINCE OF SORSOGON, THROUGH ITS MUNICIPAL MAYOR, HONORABLE TEODORO B. DE GUZMAN, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE BENJAMIN S. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, it is the desire of the Municipality of Donsol, Province of Sorsogon to expand its horizon through linkages with other local government units, thus, opening the opportunity for community development and nation building;

WHEREAS, the Municipality of Donsol, Province of Sorsogon, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila with the objective of promoting and enhancing mutual understanding, and fostering meaningful exchange of ideas in the areas of technology, health, human development, sustainable tourism and development and others;

WHEREAS, a bonding tie of sisterhood between the Municipality of Donsol, Province of Sorsogon and Mandaluyong City, Metro Manila will foster mutual friendship and goodwill, nurture closer relationship among their people and closer social and cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Donsol, Province of Sorsogon.


NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Donsol, Province of Sorsogon, through its Municipal Mayor, Hon. Teodoro B. De Guzman, and further authorizing the City Mayor, Hon. Benjamin S. Abalos, to sign the sisterhood pact.

Let copy of this Resolution be furnished to the Honorable City Mayor Benjamin S. Abalos, the Municipality of Donsol, Province of Sorsogon through its Municipal Mayor, Honorable Teodoro B. De Guzman, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.

ADOPTED on this 8th day of August 2024, in the City of Mandaluyong.


