ADOPTED on this 12th day of August 2024, in the City of Mandaluyong.

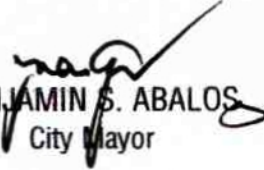
