RESOLUTION NO. 3490, S-2024

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE DEED OF DONATION AND OTHER RELATED AGREEMENTS WITH RITE-TECH MARKETING FOR THE DONATION OF VARIOUS MEDICAL EQUIPMENT FOR THE USE OF MANDALUYONG CITY MEDICAL CENTER (MCMC)

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 provides that, every local government unit shall exercise, among other powers, such other powers which are essential to the promotion of the general welfare and ensure and support, among other things, the promotion of health and safety, maintenance of peace and order, and the preservation of the comfort and convenience of their inhabitants;

WHEREAS, in its continuous pursuit to deliver basic health services to and address health concerns faced by its constituents, the City of Mandaluyong has consistently forged links to public and private entities towards the advancement of its already-progressing health stature;

WHEREAS, Rite-Tech Marketing ("Rite-Tech") is the authorized distributor of Beckman Coulter, Furuno Electric Co. Ltd., and Erba Mannheim products in the Philippines, with such products being utilized for the testing and analysis of persons undergoing clinical examinations;

WHEREAS, Rite-Tech, with sincere generosity, intends to donate to the City of Mandaluyong several medical equipment in order for the City of Mandaluyong and the Mandaluyong City Medical Center to capacitate itself of advanced medical technologies;

WHEREAS, in return, the City, with utmost gratitude, willingly accepts such donation and expresses its sincerest appreciation and gratitude for the kindness and liberality shown by Rite-Tech;

WHEREAS, relative thereto, a draft Deed of Donation has been prepared in order to espouse the intent of the parties to facilitate the transfer of the said equipment;

WHEREAS, as reviewed by the City Legal Department of Mandaluyong, the Deed appears to be reasonable as to their terms and responsive to the needs of the City;


WHEREAS, the Local Government Code requires that a Sanggunian Resolution be issued first before the Local Chief Executive may be authorized to sign contracts in representation of the local government unit.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Deed of Donation and other related agreements with Rite-Tech Marketing for the donation of various medical equipment for the use of Mandaluyong City Medical Center (MCMC).

RESOLVED FINALLY, that copy of this Resolution be furnished to the Mandaluyong City Medical Center and Rite-Tech Marketing, for their guidance and information.


