### RESOLUTION NO. 3492, S-2024

A RESOLUTION RECOMMENDING THE APPOINTMENT OF MR. FERNANDO "DONG" SUAREZ OCAMPO AS MEMBER OF THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG CITY IN VIEW OF THE PERMANENT VACANCY CAUSED BY THE PASSING OF HONORABLE COUNCILOR MICHAEL REDUTA OCAMPO IN ACCORDANCE WITH SECTION 45 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, the Sangguniang Panlungsod of Mandaluyong City and Mandaleños all over the City deeply mourn the passing of Honorable Councilor Michael Reduta Ocampo on 10 August 2024:

WHEREAS, Councilor Mike, as he is fondly known, has been championing relevant advocacies for the overall betterment and general welfare of the constituents of the City, backed by genuine love, humility, and generosity;

WHEREAS, across his time of service in the City of Mandaluyong since 2004, Councilor Mike has been an advocate of relevant and progressive advancements towards the growth and development of our Tiger City;

WHEREAS, more than his four (4) terms of service as a City Councilor and a total of forty four (44) years of being a public servant, his relentless passion and drive to serve the people became his consistent characteristic, thus winning the hearts of the people of Mandaluyong throughout these years;

WHEREAS, due to his untimely death, there exists a need to fill-in the permanent vacancy created to consistently discharge the functions left by Councilor Mike while providing unhampered representation to the constituents of the City, all of which likewise necessitating compliance with the relevant provisions of Republic Act No. 7160 or the Local Government Code of 1991:

WHEREAS, the said Code provides for the rules on the filling-up of permanent vacancies in the Sanggunian, particularly Section 45 on Permanent Vacancies in the Sanggunian which states that, (P)ermanent vacancies in the sanggunian "where automatic succession provided above do not apply shall be filled by appointment in the following manner: (a) The President, through the Executive Secretary, in the case of the Sangguniang Panlalawigan and the Sangguniang Panlangsod of highly urbanized cities and independent component cities";

WHEREAS, the Sangguniang Panlungsod of the City, as a united Council, intends to put forth its recommendation to appoint former Councilor Fernando "Dong" Suarez Ocampo to succeed and occupy the vacated position of the late Hon. Councilor Michael Reduta Ocampo;

WHEREAS, Mr. Ocampo has previously served as a City Councilor of Mandaluyong City, serving his initial term in 2013 and re-elected during the 2016 local elections under the Partido Demokratiko Pilipino – Lakas ng Bayan (PDP-LABAN), the political party of the late Hon. Councilor Michael R. Ocampo at the time of his election in 2022;

WHEREAS, Mr. Ocampo, throughout his tenure, represented the people from the marginalized sector while putting forth his advocacy on livelihood and the protection of cooperatives across the City;

WHEREAS, prior to his previous election as a City Councilor, he likewise served as a Barangay Kagawad for Barangay Hulo in 2010, thus experiencing grassroots development early in his political career which eventually came to triumphant entry to the City Council in 2013;

WHEREAS, being assured of the necessary representation of the late Honorable Councilor Michael Reduta Ocampo through the unified tenets espoused by the former being shared by Mr. Ocampo, the nomination of the latter would be monumental for this Sangguniang Panlungsod, as it consistently aspires for better days for the people of the City.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to recommend the appointment of MR. FERNANDO "DONG" SUAREZ OCAMPO as member of the Sangguniang Panlungsod of Mandaluyong City in view of the permanent vacancy caused by the passing of Honorable Councilor Michael Reduta Ocampo in accordance with Section 45 of the Local Government Code of 1991.

RESOLVED FURTHER, that MR. FERNANDO "DONG" SUAREZ OCAMPO shall serve the unexpired term of the vacant office caused by the afore-cited circumstance.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Department of the Interior and Local Government (DILG) and all other offices related to the nomination and eventual appointment of MR. FERNANDO "DONG" SUAREZ OCAMPO, as may be required by law, for their information and guidance.

RESOLVED FINALLY, this Resolution shall take effect immediately upon its approval.






