UMALI's experiences include: Laborer from February 1990 to June 30, 1990; Computer Operator III from July 1, 1990 to June 15, 1994; Information Systems Analyst II from June 16, 1994 to May 15, 1997 at the Electronic Data Processing Office; Computer Programmer III from May 16, 1997 to January 31, 2002; Information Technology Officer I from February 01, 2002 to July 31, 2006 at the Information Technology Division; Public Services Officer IV from August 01, 2006 to December 01, 2019 at the Senior Citizen Affairs Division; City Government Department Head II from December 02, 2019 to August 31, 2024 at the City Barangay Affairs and Community Services Department;

WHEREAS, her appointment as City Government Department Head II in the Gender and Development Department is considered as a lateral transfer premised on her qualifications, familiarity with the job, accomplishments in the past, trainings and work experience, known probity and competence that has gained the trust and respect of the appointing authority stemmed from her exceptional performance as the GAD Focal Person;


