**RESOLUTION RATIFYING AND CONFIRMING THE  
APPOINTMENT OF MR. ROALD R. ARCANGEL AS  
CITY GOVERNMENT DEPARTMENT HEAD II IN THE  
CITY DISASTER RISK REDUCTION AND

WHEREAS, MR. ROALD R. ARCANGEL was appointed by the Honorable City Mayor BENJAMIN S. ABALOS as City Government Department Head II in the City Disaster Risk Reduction and Management Department on September 1, 2024;

WHEREAS, MR. ROALD R. ARCANGEL graduated with a degree in Bachelor of Arts in Political Science at the Colegio de San Juan de Letran in 1998 and Master in Public Administration at the University of Santo Tomas in 2003; He has a CSC Career Service Professional eligibility which he passed in 2019 and a Barangay Official Eligibility as a Sangguniang Kabataan Chairman of Barangay New Zaniga;

WHEREAS, MR. ROALD R. ARCANGEL's experiences include: Kagawad Sangguniang Kabataan 1992-1996; Chairman, Sangguniang Kabataan 1996-2002 in Barangay New Zaniga; Administrative Officer at the Metro Manila Development Authority from March 16, 2003 to March 15, 2004; College Instructor at Jose Rizal University from October 26, 2006 to March 28, 2008; On September 17, 2007, he was appointed as Community Affairs Officer II up to February 11, 2008; Administrative Assistant II from March 11, 2008 - March 15, 2016; LDRRM Assistant from March 16, 2016 to December 31, 2018; Officer-in-Charge/LDRRM Assistant from October 17, 2018 to March 15, 2019; LDRRM Assistant from January 1, 2019 - May 18, 2020 and as LDRRM Officer IV from May 19, 2020 to August 31, 2024 at the Office of the Mayor;

WHEREAS, his appointment as City Government Department Head II in the City Disaster Risk Reduction and Management Department is considered as a promotion premised on his qualifications, familiarity with the job, accomplishments in the past, trainings and work experience, known probity and competence that has gained the trust and respect of the appointing authority;



ADOPTED on this 23<sup>rd</sup> day of September 2024, in the City of Mandaluyong.


