MARANAN graduated with a degree in BS Physical Therapy at the Emilio Aguinaldo College in Manila in 1997 and a Master in Public Administration at the Jose Rizal University in 2019; She has a CSC Professional PPT eligibility which she passed in March 2024 and a Barangay Eligibility as a Sangguniang Kabataan Chairman of Barangay Poblacion;

WHEREAS, MS. JENNILYN V. MARANAN served as Executive Assistant to the Vice President/Document Controller, Research and Development at the Mega Data Corporation from June 28, 1998 to August 15, 2004. Her government services include: Utility Worker I from August 19, 2004 to December 31, 2005, Administrative Aide I from January 01, 2006 to December 31, 2012, Administrative Officer 1 from January 01, 2013 to December 31, 2013; Administrative Assistant VI from January 1, 2014 to March 23, 2018 at the Administrative Services Division; Youth Development Officer from March 24, 2018 to August 31, 2024 at the Mandaluyong Youth Development Office and as Officer-in-Charge at the City Garden of Life from May 2, 2024 to present;

WHEREAS, her appointment as City Government Department Head II in the City Garden of Life Memorial Park Department is considered as a promotion premised on his qualifications, familiarity with the job, accomplishments in the past, trainings and work experience, known probity and competence that has gained the trust and respect of the appointing authority;


