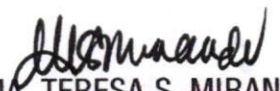

ADOPTED on this 21th day of October 2024, in the City of Mandaluyong.

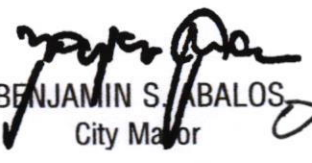
