ADOPTED on this 25th day of November 2024, in the City of Mandaluyong.

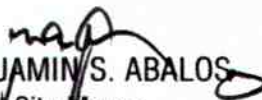

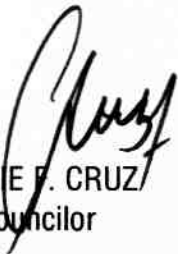
