**RESOLUTION ACKNOWLEDGING AND RECOGNIZING THE
UPDATED LOCAL LIST OF CULTURAL PROPERTIES
SUBMITTED BY THE CITY CULTURAL AFFAIRS AND
TOURISM DEPARTMENT OF THE CITY OF
MANDALUYONG**

WHEREAS, Republic Act No. 10066 or the National Cultural Heritage Act of 2009 has tasked the National Commission for Culture and the Arts (NCCA), the overall policy-making and coordinating agency for culture and arts, to establish and maintain the Philippine Registry of Cultural Property (PRECUP);

WHEREAS, under the said law, Local Government Units are specifically mandated to maintain an inventory of cultural property under its jurisdiction and to furnish the NCCA a copy of its local inventory. In order to further carry out its provision, the NCCA has established the Cultural Mapping Program to assist LGUs in this endeavor;

WHEREAS, in compliance thereof, Ordinance No. 606, S-2015 enacted on August 10, 2015 mandated the cultural mapping of historical and heritage sites in the City of Mandaluyong. Thereafter, the Cultural Affairs and Tourism Department of the City of Mandaluyong has submitted to the National Commission for Culture and the Arts a list of cultural properties, together with a written account of all areas which are rich in heritage and culture in the City for the Cultural Mapping Program of the City of Mandaluyong;

WHEREAS, on May 09, 2017, the City Government of Mandaluyong, represented by the Honorable City Mayor CARMELITA A. ABALOS entered into a Memorandum of Understanding with the National Commission for Culture and the Arts (NCCA), represented by its Chairman, the Honorable VIRGILIO S. ALMARIO, to support, undertake, implement, document and disseminate the Cultural Mapping Program;

WHEREAS, on March 28, 2022, the Sangguniang Panlungsod of Mandaluyong adopted Resolution No. 3086, S-2022 or the Resolution Acknowledging and Recognizing the Attached Local List of Cultural Properties submitted by the City Cultural Affairs and Tourism Department of the City of Mandaluyong;

WHEREAS, on July 17, 2023, the Sangguniang Panlungsod of Mandaluyong adopted Resolution No. 3306, S-2023 or the Resolution Acknowledging and Recognizing the Updated Local List of Cultural Properties submitted by the City Cultural Affairs and Tourism Department of the City of Mandaluyong

WHEREAS, on January 8, 2024, the Sangguniang Panlungsod of Mandaluyong adopted Resolution No. 3381, S-2024 or the Resolution Acknowledging and Recognizing the Attached Local List of Cultural Properties submitted by the City Cultural Affairs and Tourism Department of the City of Mandaluyong

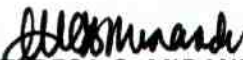

ADOPTED on this 13th day of January 2025, in the City of Mandaluyong.

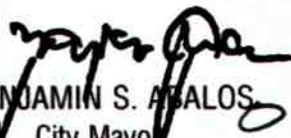
