**RESOLUTION ACKNOWLEDGING AND
RECOGNIZING THE BUST OF LEONARD WOOD,
WHO SERVED AS THE GOVERNOR GENERAL IN
THE PHILIPPINES, AS AN IMPORTANT
CULTURAL PROPERTY SUBMITTED BY THE CITY
CULTURAL AFFAIRS AND TOURISM
DEPARTMENT OF THE CITY OF MANDALUYONG**

WHEREAS, the 1987 Constitution mandates the State to conserve, develop and promote and popularize the nation's historical and cultural heritage and resources, as well as artistic creations. It further provides that, all the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State, which may regulate its disposition;

WHEREAS, Republic Act 10066 or the National Cultural Heritage Act of 2009 endeavors to create a balanced atmosphere where the historic past co-exists in harmony with modern society. It aims to establish and strengthen culture institutions, protect, preserve, conserve and promote the nation's cultural heritage, its property and histories, and ethnicity of local communities;

WHEREAS, Section 5 of R.A. 10066 and the 1987 Constitution, for the purpose of protecting a cultural property against exportation, modification or demolition, the following works shall be considered important cultural property, unless declared otherwise by the pertinent cultural agency: xxx any important cultural property dating at least fifty (50) years old;

WHEREAS, Section 16 of R.A. 7160 or the Local Government Code of 1991, provides that local government units play an important role in the development, promotion and preservation of Filipino culture and encourage the participation of the people in the development and preservation of Filipino identity;

WHEREAS, Leonard Wood was a United States Army Major General, physician, and public official. He served as the Governor-General of the Philippines from October 14, 1921 to August 7, 1927;

WHEREAS, the City Cultural Affairs & Tourism Department is submitting updated list of cultural properties for the year 2025 in compliance with RA 10066 that shall aid the City in receiving the most coveted Seal of Good Local Governance (SGLG) by every Local Government Unit in recognition of Mandaluyong's distinct and remarkable good governance performance;

WHEREAS, MR. NOLAN V. ANGELES, Department Head of the City Cultural Affairs and Tourism Department, in his letter dated January 22, 2025 requested for a resolution acknowledging and recognizing the updated local list of cultural properties, (Tangible and Intangible) of the City of Mandaluyong. Appendix A forms an Integral part of this Resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled, as it hereby RESOLVES, to acknowledge and recognize the local list of Cultural properties submitted by the City Cultural Affairs and Tourism Department of the City of Mandaluyong in support of the updating of the Cultural Mapping Program of the City of Mandaluyong.
