A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE QUADRIPARTITE AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY, POLYTECHNIC UNIVERSITY OF THE PHILIPPINES, PHILIPPINE INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS - METRO MANILA REGION - GEOGRAPHICAL AREA OFFICE AND THE CITY GOVERNMENT OF MANDALUYONG TIGER CITY NEGOSYO CENTER FOR THE CONDUCT OF THE PROGRAM AND WEBINAR SERIES ENTITLED "ACCOUNTING, FOR NON-ACCOUNTANTS"

WHEREAS, the Go Negosyo Act or RA 10644 provides for the policy of the State to foster national development, promote inclusive growth, and reduce poverty by encouraging the establishment of micro, small and medium enterprises (MSMEs) that facilitate local job creation, production and trade in the country;

WHEREAS, the Department of Trade and Industry (DTI), as the national government agency that serves as the regulatory arm of the government for the country's trade, industry, and investment activities, is now currently setting up Negosyo Centers in the country to serve as one-stop business centers in order to provide technical expertise to would-be entrepreneurs;

WHEREAS, the state university, Polytechnic University of the Philippines (PUP), and the umbrella organization of all certified public accountants in the country, Philippine Institute of Certified Public Accountants – Metro Manila Region-Geographical Area Office (PICPA-MMR-GAO), jointly developed a program or webinar series called "Accounting, for Non-Accountants" geared for the MSMEs and local communities:

WHEREAS, the City Government of Mandaluyong, via the Office of the Mayor's Tiger City Negosyo Center, in the performance of its function under Ordinance No. 607, S-2015 specifically to provide information and services in training, financing and marketing, is willing and able to work in partnership with the DTI, PUP and PICPA-MMR-GAO for the conduct of the webinar series entitled "Accounting, for Non-Accountants" in Mandaluyong, in order to be able to extend such technical expertise to the City of Mandaluyong's would-be entrepreneurs;

WHEREAS, a Quadripartite Agreement has been drafted to cover this collaboration of DTI, PUP, PICPA-MMR-GAO and the City Government of Mandaluyong's Tiger City Negosyo Center;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Quadripartite Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable City Mayor CARMELITA A. ABALOS to enter into and sign the Quadripartite Agreement with the Department of Trade and Industry, Polytechnic University of the Philippines, Philippine Institute of Certified Public Accountants - Metro Manila Region-Geographical Area Office, and the City Government of Mandaluyong's Tiger City Negosyo Center for the conduct of the program and webinar series entitled "Accounting, for Non-Accountants".
