## RESOLUTION NO. 3665, S-2025

A RESOLUTION RECOMMENDING TO ALL THEATER OWNERS IN THE CITY OF MANDALUYONG TO ADD A TWO-PESO (P2.00) VOLUNTARY MOVIE TICKET SURCHARGE FOR THE PERIOD DECEMBER 1, 2025 TO DECEMBER 31, 2025 AND REMIT THE SAME TO THE GIRL SCOUTS OF THE PHILIPPINES, MANDALUYONG CITY COUNCIL

WHEREAS, the Girl Scouts of the Philippines is a non-income generating organization that helps in empowering girls and young women to become responsible citizens of the community and partners in nation-building;

WHEREAS, because of lack of funds for its various programs and activities, the Girl Scouts of the Philippines, Mandaluyong City Council requested, for all movie owners operating in the City of Mandaluyong to add a Two-Peso (P2.00) movie ticket surcharge as voluntary contribution to the Girl Scouts of the Philippines, Mandaluyong City Council. The proceeds shall go to the Girl Scouts of the Philippines Mandaluyong City Council's fund and will be used in support of its mission to help girls and young women realize the ideals of womanhood and prepare themselves for their responsibilities in the home, to the nation and the world community;

WHEREAS, this Sangguniang Panlungsod took notice of the many programs and activities of the Girl Scouts of the Philippines, Mandaluyong City Council, that prepares Girl Scouts for their responsibilities in the nation-building. However, these programs and activities could not be implemented because of their limited financial resources. The funds generated from the movie ticket surcharge in the past years have helped a lot the girl scouts and teachers. This is manifested by the various awards and recognitions received by the Girl Scouts of the Philippines, Mandaluyong City Council, through the years;

WHEREAS, the Sangguniang Panlungsod, consistent with the tradition of giving its unwavering support to the Girl Scouts of the Philippines, Mandaluyong City Council, finds the request meritorious and resolves to support its request for a Two-Peso (P2.00) movie ticket surcharge.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong City, in session duly assembled RESOLVED, as it hereby RESOLVES, to approve the request of the Girl Scouts of the Philippines, Mandaluyong City Council, for all theater owners in the City of Mandaluyong to add a Two-Peso (P2.00) voluntary movie ticket surcharge for the period December 1–31, 2025.

RESOLVES, FURTHER, that a copy of this Resolution be furnished the City Treasurer and the Girl Scouts of the Philippines, Mandaluyong City Council, with the latter providing a copy to the theater owners/operators for their information and guidance.

RESOLVED, FURTHERMORE, to require Girl Scout of the Philippines, Mandaluyong City Council to submit a report of the remittance within ten (10) days from receipt thereof to the Office of the City Mayor, copy furnished the Sangguniang Panlungsod of Mandaluyong.

ADOPTED on this 3rd day of September 2025, in the City of Mandaluyong.
