## RESOLUTION NO. 3667, S-2025

A RESOLUTION AUTHORIZING THE CITY OF MANDALUYONG. THROUGH THE LOCAL CHIEF EXECUTIVE. HONORABLE CITY MAYOR CARMELITA A. ABALOS, TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON AUGUST 23, 2025 AT NO. 586 NUEVE DE FEBRERO STREET, BARANGAY ADDITION HILLS, MANDALUYONG

WHEREAS, based on the validated fire disaster report of the Mandaluyong City Social Welfare and Development Department, in coordination with the Bureau of Fire Protection, on August 23, 2025 at about 9:58 P.M, a fire occurred at No. 586 Nueve de Febrero Street, Barangay Addition Hills, Mandaluyong City which broke out and spread to the affected area;

WHEREAS, based on the City Social Welfare and Development Department report, the fire incident rendered One (1) validated fire affected family or Five (5) individuals as their structure were partially burned/damaged by the fire:

WHEREAS, it is the thrust of the City Government of Mandaluvong to provide sincere and efficient public service to its constituents, especially in times of crisis and emergencies, thus, deeming necessary to extend financial assistance to the affected families and individuals:

WHEREAS, the City Mayor, distraught by this fire disaster, has initiated to grant financial assistance to the affected family amounting to Fifteen Thousand Pesos (₱15,000.00) per house owner (1 house owner). The total amount of Fifteen Thousand Pesos (₱15,000.00) financial assistance shall be chargeable against the Calamity Fund or Quick Response Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF), subject to accounting and COA auditing laws, rules and regulations:

WHEREAS, said grant of financial assistance to those affected fire victims merits the consideration of the Sangguniang Panlungsod of Mandaluvong in accordance with the mandated duty of the City to help and promote the welfare of its constituents.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City of Mandaluyong, through the Local Chief Executive, Honorable City Mayor Carmelita A. Abalos, to grant financial assistance to the victims of fire that occurred on August 23, 2025 at No. 586 Nueve de Febrero Street, Barangay Addition Hills, Mandaluyong City.

RESOLVED, FINALLY, that copy of this Resolution be furnished the Honorable City Mayor CARMELITA A. ABALOS at the Office of the City Mayor, and the respective Mandaluyong City Disaster Risk Reduction and Management Department (MCDRRMD) and City Social Welfare and Development Department, for their immediate information and appropriate action.
