RESOLUTION RECOGNIZING TWO (2)
NON-GOVERNMENTAL ORGANIZATIONS AS CIVIL
SOCIETY ORGANIZATIONS IN THE
CITY OF MANDALUYONG

WHEREAS, the following Organizations based in the City of Mandaluyong, have sought recognition before this Sanggunian pursuant to the provision of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" and its Implementing Rules and Regulations:

1. NUEVE DE FEBRERO NEIGHBORHOOD ASSOCIATION
2. BAGONG SAMAHAN NEIGHBORHOOD ASSOCIATION

WHEREAS, the aforementioned Non-Governmental Organizations have partially complied with the requirements prescribed under the Department of the Interior and Local Government Memorandum Circular No. 2025-060 issued on June 23, 2025, hence, the Committee recommends recognizing the associations as Civil Society Organizations (CSOs) in the City of Mandaluyong;




