RESOLUTION NO. 3676, S-2025

A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF PADRE GARCIA, PROVINCE OF BATANGAS THROUGH ITS MUNICIPAL MAYOR, HONORABLE CELSA B. RIVERA, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE CARMELITA A. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, it is the desire of the Municipality of Padre Garcia, Province of Batangas to expand its horizon through linkages with other local government units, thus, opening opportunities for economic, cultural and social development;

WHEREAS, the Municipality of Padre Garcia, Province of Batangas, by virtue of RESOLUTION NO. 90-2025, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to strengthen friendship ties and "to create opportunities for exchanging best practices, sharing knowledge and working together on projects contributing to overall progress and development";

WHEREAS, a bonding tie of sisterhood between the Municipality of Padre Garcia, Province of Batangas and Mandaluyong City, Metro Manila will promote mutual friendship and goodwill, foster closer relationship among their respective constituents and create socio-cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Padre Garcia, Province of Batangas.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Padre Garcia, Province of Batangas through its Municipal Mayor, Hon. Celsa B. Rivera, and further authorizing the City Mayor, Hon. Carmelita A. Abalos, to sign the sisterhood pact.

RESOLVED FURTHER, that the Local Chief Executive of Padre Garcia, is hereby authorized to undertake necessary steps to conduct negotiations with the Local Government Unit of Mandaluyong, City towards the establishment of a sisterhood agreement.

RESOLVED FINALLY, that copy of this Resolution be furnished to the Honorable City Mayor Carmelita A. Abalos, the Municipality of Padre Garcia, Province of Batangas through its Municipal Mayor, Honorable Celsa B. Rivera, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.

ADOPTED on this 24th day of September 2025, in the City of Mandaluyong.




