RESOLUTION NO. 3679, S-2025

**A RESOLUTION ADOPTING THE  
MANDALUYONG CITY PEACE AND ORDER  
AND PUBLIC SAFETY (POPS) PLAN FOR  
CALENDAR YEARS 2026, 2027, AND 2028**

WHEREAS, Executive Order No. 773, series of 2009, as amended, mandates every city and municipality to organize its respective Local Peace and Order Council (LPOC);

WHEREAS, Department of the Interior and Local Government (DILG) Memorandum Circular No. 2015-128 mandates the formulation of a three-year Local Peace and Order and Public Safety (POPS) Plan to be incorporated in the Comprehensive Development Plan;

WHEREAS, DILG Memorandum Circular No. 2019-143 provides the Omnibus Guidelines for Peace and Order Councils (POCs), harmonizing existing policies affecting POCs and providing additional guidelines concerning the formulation of the Peace and Order and Public Safety Plan (POPSP), the POPSP Policy Compliance Monitoring System (POPSP-PCMS), and the POC Performance Audit;

WHEREAS, the Mandaluyong City Peace and Order Council (MCPOC) was reorganized through Executive Order No. 7, series of 2025, and has formulated its Local Peace and Order and Public Safety Plan for Calendar Years 2026, 2027, and 2028;

WHEREAS, the Mandaluyong City Peace and Order and Public Safety Plan for CYs 2026–2028 was presented, deliberated upon, and approved by the members of the MCPOC during its regular meeting held on September 3, 2025;

WHEREAS, the Sangguniang Panlungsod of Mandaluyong recognizes the importance of adopting the said plan as a strategic framework to ensure peace, order, and public safety within the City.

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session duly assembled, to ADOPT the Mandaluyong City Peace and Order and Public Safety (POPS) Plan for Calendar Years 2026, 2027, and 2028.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Mandaluyong City Peace and Order Council (MCPOC), the Department of the Interior and Local Government (DILG), the Regional Peace and Order Council (RPOC) Secretariat, and all concerned agencies for their information, guidance, and appropriate action.

ADOPTED on this 24<sup>th</sup> day of September 2025, in the City of Mandaluyong.




