RESOLUTION NO. 3688, S-2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH LOVEYOURSELF, INC. ESTABLISHING THEIR PARTNERSHIP AND THE SPONSORSHIP OF THE LATTER'S "LOVE GALA" EVENT ON NOVEMBER 8, 2025

WHEREAS, Section 11, Article 2 of the 1987 Philippine Constitution provides for the commitment of the State to value the dignity of every person and the guarantee of full respect for human rights;

WHEREAS, in furtherance of this mandate and to further reconcile the efforts of the National Government with those of the local government units, a holistic approach towards achieving this commitment is necessary, thus, the involvement of local government units in the process;

WHEREAS, this is in keeping with Section 16 of the Local Government Code (LGC), which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the same is further supported by the mandate of local government to ensure and support the improvement of public morals and enhancement of social justice, as provided under the same section of the Code;

WHEREAS, as a stakeholder in the community, LoveYourself, Inc., one of the country's leading organizations in HIV awareness, testing, and treatment housed in the City of Mandaluyong, has been a steadfast partner of the City Government in furthering its projects and programs relating to health and social hygiene, powered by approximately 1800 volunteers;

WHEREAS, LoveYourself, Inc. has established 7 clinics and 15 community centers in the country, ranking as the top most visited in the country for HIV screening while revolutionizing sexual health awareness through the establishment of the first transgender health clinic in the Philippines called Victoria by LoveYourself – as proof of its unending commitment to its purpose and objectives;

WHEREAS, to celebrate the domestic and global movement towards HIV and AIDS advocacy and recognize Filipinos who revolutionized the landscape of HIV and AIDS awareness across the country, LoveYourself, Inc. shall hold its upcoming annual event called "Love Gala" on 08 November 2025;

WHEREAS, the City seeks to expand its advocacies and initiate programs, projects, and partnerships geared towards nurturing its existing HIV and AIDS awareness system in place, creating an environment which welcomes full access and capacity for HIV testing and treatment, and eradicating the stigma and discrimination against people living with HIV and AIDS by expressing its willingness to support the event by providing the event venue and food and catering subject to terms that ensure transparency, fairness, and mutual benefit;

WHEREAS, the parties crafted a proposed Memorandum of Agreement to set out the details and guidelines of the partnership;

WHEREAS, with the same having been already reviewed by the City Legal Department coupled with the assurance of the parties of their compliance with their respective duties and responsibilities, the said document appears to be in accordance with the law and is reasonably and properly crafted;

WHEREAS, for the execution of the said document, there exists a need to authorize the City Mayor, Honorable Carmelita A. Abalos, to enter into and sign the Memorandum of Agreement between the City Government of Mandaluyong and LoveYourself, Inc. and act on behalf of the City Government of Mandaluyong, through an appropriate Sangguniang Panlungsod resolution.



ABALOS to enter into and sign the Memorandum of Agreement with LoveYourself, Inc. regarding their partnership and the sponsorship to be provided by the City of Mandaluyong for its "Love Gala" event to be held on 08 November 2025.

RESOLVED FINALLY, this Resolution shall take effect immediately upon its approval.

ADOPTED on this 13th day of October 2025, in the City of Mandaluyong.




