RESOLUTION NO. 3689, S-2025

**A RESOLUTION EXPRESSING MANDALUYONG CITY'S
WILLINGNESS AND FIRM INTENT TO PARTICIPATE IN
AND EXTEND FULL SUPPORT TO THE OPEN
GOVERNMENT PARTNERSHIP LOCALIZATION**

WHEREAS, the Philippine Open Government Partnership (PH-OGP) was institutionalized under Executive Order No. 31, series of 2023, as a mechanism for the delivery of more effective and sustainable actions to address current social concerns;

WHEREAS, under Section 3 of the said E.O. the PH-OGP is mandated to integrate open and inclusive governance principles into national and local government processes;

WHEREAS, Section 47 of the General Provisions under the General Appropriations Act for FY 2025 mandates the adoption of open government partnership values of transparency, accountability, citizen participation, and leveraging on technology in the implementation of programs, activities and projects;

WHEREAS, the 6th PH-OGP National Action Plan 2023–2027 contain commitments from the government which was co-created through a multi-stakeholder process and embody a concrete set of action composed of government programs that conform to the OGP values;

WHEREAS, the Department of the Interior and Local Government, being a member of the PH-OGP Steering Committee and a commitment holder in the 6th National Action Plan, is proposing to tap more local governments to be active in the promotion of the OGP values through an OGP Localization Plan;

WHEREAS, based on the documentation and profiling of open government practices in the National Capital Region conducted by the Institute of Politics and Governance, and the thorough selection process by the Regional Technical Working Group from DILG-NCR, DBM-NCR, and CSO partners from Bayan Family of Foundations, Catholic Relief Services, and Advocacies for Praxis for Leadership and Community Development, the City Government of Mandaluyong has been identified as highly qualified to take part in the first cohort members of the PH-OGP Localization;

WHEREAS, Honorable Mayor Carmelita A. Abalos, in her transmittal letter dated October 7, 2025, requested the passage of a City Council Resolution expressing the City's willingness and firm intent to participate in and extend full support to the OGP localization as part of the City's continued effort in upholding the principles of transparency, accountability and participatory governance.

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session duly assembled, to adopt and approve this Resolution expressing the willingness and firm intention of the City Government of Mandaluyong to participate in and extend full support to the localization of the Open Government Partnership (OGP), as a formal affirmation of the City's commitment to uphold, sustain, and further strengthen open government principles and practices.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Department of the Interior and Local Government-National Capital Region through the DILG-Mandaluyong City Field Office, the City Planning and Development Department, CSO Desk Officer, and all concerned agencies for their information, guidance and appropriate action.
