RESOLUTION NO. 3694, S-2025

A RESOLUTION AUTHORIZING ENGR. LUIS EDUARD L. TEODORO FOR AND IN BEHALF OF THE CITY OF MANDALUYONG TO BRING, FILE, OR INSTITUTE ANY OR ALL ACTIONS AGAINST JOHN CHRISTOPHER OCAMPO SERRANO AND OTHER UNIDENTIFIED PERPETRATORS REMAINING AT LARGE INVOLVED IN THE PILFERAGE AND STEALING OF CITY-OWNED PROPERTIES, SUCH AS STREETLIGHTS AND WIRES, WHICH OCCURRED ON OCTOBER 14, 2025 AND RATIFYING ALL HIS PREVIOUS ACTS RELATING TO THE SAME

WHEREAS, the Sangguniang Panlungsod of each applicable local government unit exercises, along with those particularly mentioned in the Local Government Code of 1991, such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, Section 22 (a) (2) of the Local Government Code of 1991 provides for the power of every local government unit to sue and be sued;

WHEREAS, in consonance with the afore-cited provisions and consistent with the duty of the City Government of Mandaluyong to maintain peace and order within its jurisdiction, it is necessary that the City, through the affirmative act of this Sangguniang Panlungsod, authorize the appropriate officials and employees of the local government unit to bring, file, or institute the appropriate cases and actions towards achieving this duty;

WHEREAS, on October 14, 2025, several employees of the Traffic and Parking Management Department of the City Government of Mandaluyong arrested John Christopher Ocampo Serrano, with several other unidentified individuals remaining at large, after they were caught in the act of pilferage of several City-owned properties;

WHEREAS, upon the arrest of John Christopher Ocampo Serrano, the appropriate legal processes were undertaken through the local Philippine National Police and the Office of the City Prosecutor;

WHEREAS, to aid and assist in the prosecution of such action, the City Engineering Department, through City Engineer Crisanto W. Roxas, identified Engr. Luis Eduard L. Teodoro from its Electrical Section to be the authorized representative of the Department and the City Government of Mandaluyong to initiate such action, as he is personally knowledgeable with the properties subject of the pilferage and the incidents of the case;

WHEREAS, with such proceedings against John Christopher Ocampo Serrano and those perpetrators who remain at large having been initiated, it is necessary that this Sangguniang Panlungsod vest Engr. Luis Eduard L. Teodoro with the appropriate authority to bring, file, and institute appropriate actions and ratify his previous acts relating to such purpose;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize ENGR. LUIS EDUARD L. TEODORO to bring, file, and institute any or all actions against John Christopher Ocampo Serrano and the other unidentified perpetrators remaining at large involved in the pilferage and stealing of City-owned properties, such as streetlights and wires, and ratifying all his previous acts relating to such purpose.

RESOLVED FURTHER, that copies of this Resolution be furnished to the City Engineering Department, the local PNP, and the Office of the City Prosecutor for their information and guidance.

RESOLVED FINALLY, this Resolution shall take effect immediately upon its approval.


