**RESOLUTION GRANTING ACCREDITATION TO

(CSOs) THAT HAVE COMPLIED WITH THE
REQUIREMENTS OF DILG MEMORANDUM
CIRCULAR NO. 2025-060**

WHEREAS, the following Organizations based in the City of Mandaluyong, have sought recognition before this Sanggunian pursuant to the provisions of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" and its Implementing Rules and Regulations:


