RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2025 TO INCLUDE THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES TO BE COVERED BY SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2025

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the year 2025;

WHEREAS, due to the exigencies of public service and maximize the utilization of funds before the year ends, there are various programs, projects and activities (PPAs) that need to be adopted, funded, and implemented by different offices of the City Government of Mandaluyong;

WHEREAS, the sources of funds for these various PPAs have been identified and will be appropriated through Supplemental Budget No. 2 for CY 2025;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include those PPAs covered by the Supplemental Budget No. 2 for CY 2025;

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm the Supplemental Annual Investment Program (AIP) for Calendar Year 2025 of the City Government of Mandaluyong to include those PPAs covered by the Supplemental Budget No. 2 for Calendar Year 2025.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the Mayor, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.

ADOPTED on this 27<sup>th</sup> day of October 2025, in the City of Mandaluyong.




