RESOLUTION NO. 3702, S-2025

A RESOLUTION RECOMMENDING TO THE OWNERS/OPERATORS OF THE MOVIE HOUSES IN MANDALUYONG CITY TO ADD ONE PESO (P1.00) TO THE ADMISSION PRICE FROM JANUARY 1, 2026 TO JANUARY 31, 2026 AND REMIT THE SAME TO THE PHILIPPINE RED CROSS (PRC), MANDALUYONG CITY BRANCH

WHEREAS, it is the mission of the Philippine Red Cross (PRC) to alleviate human suffering and provide assistance to the most vulnerable and the demand for blood as a lifesaving fluid for many injured and all ill patients have increased;

WHEREAS, the Philippine Red Cross, Mandaluyong City Branch, requested the Mandaluyong City Mayor, Honorable CARMELITA A. ABALOS, to pass a Resolution authorizing the theaters and cinema houses in Mandaluyong to add a movie surcharge to their admission price for the month of January 1–31, 2026;

WHEREAS, the proceeds shall fund the continuous delivery of humanitarian services of the Philippine Red Cross (PRC) in providing assistance to our most vulnerable brothers and sisters from an appeal for medical assistance to save the life of a loved one, an appeal to find a missing family member who is possibly suffering from abuse in a foreign country, to an appeal for food from families who can barely make ends meet and to put dignity in the life of millions of Filipinos; In addition, the Team is ready to provide emergency assistance, bring to safety individuals and families in need of rescue, provide health and medical assistance, as well as help rebuild the community long after the disaster;


WHEREAS, since the request is for a noble purpose which is worthy of favorable consideration, the Sangguniang Panlungsod of Mandaluyong, by virtue of the powers vested in it by law, has decided to pass this Resolution.

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, by virtue of the powers vested in it by law, in session assembled, that:

1. The owners/operators of theaters or cinema houses in Mandaluyong City are hereby requested to help PRC, Mandaluyong City Branch and add One Peso (P1.00) to their movie ticket admission price from January 1, 2026 to January 31, 2026 and within sixty (60) days from the end of the collection period, remit the amount collected directly to the PRC, Mandaluyong City Branch. Said amount shall be exempt from payment of amusement tax;
2. The PRC, Mandaluyong City Branch is hereby required to submit a report of the remittance within ten (10) days from receipt thereof to the Office of the City Mayor, copy furnished the Sangguniang Panlungsod of Mandaluyong;
3. Let a copy of this Resolution be furnished the City Treasurer and the Philippine Red Cross (PRC), with the latter providing a xerox copy to the theater owners/operators for their information and guidance;
4. This Resolution shall take effect immediately upon approval.


