**RESOLUTION NO. 3704, S-2025**

**A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF SABTANG, PROVINCE OF BATANES THROUGH ITS MUNICIPAL MAYOR, HONORABLE TERESITA C. NEYALA, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE CARMELITA A. ABALOS, TO SIGN THE SISTERHOOD PACT**

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, it is the desire of the Municipality of Sabtang, Province of Batanes to expand its horizon through linkages with other local government units, thus, opening opportunities for economic, cultural and social development;

WHEREAS, the Municipality of Sabtang, Province of Batanes, by virtue of MUNICIPAL RESOLUTION NO. 135, S. 2025, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to promote and foster strong ties, mutual friendship and goodwill through exchange in technology, tourism, culture and arts, planning and development, commerce, trade and industry, youth education and sports, environmental protection, calamity preparedness, public health and social welfare;

WHEREAS, a bonding tie of sisterhood between the Municipality of Sabtang, Province of Batanes and Mandaluyong City, Metro Manila will promote mutual friendship and goodwill, foster closer relationship among their respective constituents and create socio-cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Sabtang, Province of Batanes;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Sabtang, Province of Batanes through its Municipal Mayor, Hon. Teresita C. Neyala, and further authorizing the City Mayor, Hon. Carmelita A. Abalos, to sign the sisterhood pact.

RESOLVED FINALLY, that copy of this Resolution be furnished to the Honorable City Mayor Carmelita A. Abalos, the Municipality of Sabtang, Province of Batanes through its Municipal Mayor, Honorable Teresita C. Neyala, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.


