RESOLUTION NO. 3706, S-2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE MUTUAL NON-DISCLOSURE AGREEMENT WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) TO PROTECT CONFIDENTIAL INFORMATION OF BOTH PARTIES DURING THE EXPLORATORY STAGE OF THE POSSIBLE IMPLEMENTATION OF THE PHILHEALTH GROUP ENROLLMENT PROGRAM IN THE CITY OF MANDALUYONG

WHEREAS, Article XIII, Section 11 of the 1987 Constitution provides that the State "shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost;"

WHEREAS, PhilHealth is a government-owned and controlled corporation which administers the National Health Insurance Program;

WHEREAS, pursuant to Republic Act No. 11223 or the Universal Health Care Act, PhilHealth is offering the Group Enrollment Program in facilitating the social health protection of workers;

WHEREAS, PhilHealth is proposing for the City of Mandaluyong to participate in the said program;

WHEREAS, pursuant to the General Welfare Provision of the Local Government Code of 1991, every local government unit must ensure the promotion of health and safety of its constituents;

WHEREAS, the City of Mandaluyong is open to explore discussions with PhilHealth regarding the Group Enrollment Program;

WHEREAS, to protect the interests of both parties, a mutual Non-Disclosure Agreement must be executed;


WHEREAS, Section 22 of the Local Government Code of 1991 gives Mandaluyong City, as represented by its Local Chief Executive, the power to enter into contracts after being authorized by the Sangguniang Panlungsod.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor Carmelita A. Abalos to enter into and sign the Mutual Non-Disclosure Agreement with PhilHealth to protect confidential information of both parties during the exploratory stage of the possible implementation of the PhilHealth Group Enrollment Program in the City of Mandaluyong.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, City Health Department, and other concerned departments of the City.




