**RESOLUTION NO. 3709, S-2025**

A RESOLUTION ENDORSING THE ESTABLISHMENT OF A SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA, AND THE MUNICIPALITY OF BAYAMBANG, PROVINCE OF PANGASINAN, THROUGH ITS MUNICIPAL MAYOR, HONORABLE MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE CARMELITA A. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that “Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them”;

WHEREAS, it is the desire of the Municipality of Bayambang, Province of Pangasinan, to expand its horizon through linkages with other local government units, thus, opening opportunities for economic, cultural and social development;

WHEREAS, the Municipality of Bayambang, Province of Pangasinan, by virtue of MUNICIPAL RESOLUTION NO. 638, S. 2025, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila, “to foster mutual understanding and goodwill between the people of Bayambang and Mandaluyong, further strengthening local autonomy and inter-LGU cooperation”;

WHEREAS, a bonding tie of sisterhood between the Municipality of Bayambang, Province of Pangasinan and Mandaluyong City, Metro Manila, will promote closer relationships among their respective constituents and create socio-cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City’s philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace, and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Bayambang, Province of Pangasinan.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of a sisterhood agreement between the City of Mandaluyong, Metro Manila, and the Municipality of Bayambang, Province of Pangasinan, through its Municipal Mayor, Honorable Mary Clare Judith Phyllis Jose-Quiambao, and further authorizing the City Mayor, Honorable Carmelita A. Abalos, to sign the sisterhood pact.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Honorable City Mayor Carmelita A. Abalos, the Municipality of Bayambang, Province of Pangasinan, through its Municipal Mayor, Honorable Mary Clare Judith Phyllis Jose-Quiambao, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.
