RESOLUTION NO. 3710, S-2025

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE DEED OF DONATION AND OTHER RELATED AGREEMENTS WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE DONATION OF ONE (1) PATIENT TRANSPORT VEHICLE THROUGH ITS MEDICAL TRANSPORT VEHICLE (MTV) DONATION PROGRAM

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 provides that every local government unit shall exercise, among other powers, such other powers which are essential to the promotion of the general welfare and ensure and support, among other things, the promotion of health and safety, maintenance of peace and order, and the preservation of the comfort and convenience of their inhabitants;

WHEREAS, in its continuous pursuit to deliver basic health services to and address health concerns faced by its constituents, the City of Mandaluyong has consistently forged links to public and private entities towards the advancement of its already-progressing health stature;

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO), acting on its intent to strengthen its commitment to public health, implements the Medical Transport Vehicle (MTV) Donation Program, wherein the PCSO provides medical transport vehicles to the Local Government Units in order to immediately and safely transport the patients to, from, and between locations with the most efficient access to places of treatment by land;

WHEREAS, with sincere generosity and as an identified LGU beneficiary, PCSO intends to donate to the City of Mandaluyong one (1) unit of a Medical Transport Vehicle to increase its health response mechanisms, with the following specifications:
