RESOLUTION NO. 3730, S-2026

A RESOLUTION AUTHORIZING THE CITY OF MANDALUYONG, THROUGH THE LOCAL CHIEF EXECUTIVE, HONORABLE CITY MAYOR CARMELITA A. ABALOS, TO GRANT FINANCIAL ASSISTANCE TO THE ADDITIONAL VICTIMS OF FIRE THAT OCCURRED ON DECEMBER 12, 2025 AT FT. EVANGELISTA, R. PASCUAL & C. FERNANDO STREET, BARANGAY PLEASANT HILLS, MANDALUYONG CITY

WHEREAS, on December 12, 2025 at about 6:30 P.M., a fire occurred at FT. Evangelista, R. Pascual & C. Fernando Street, Barangay Pleasant Hills, Mandaluyong City, causing damage to several residential structures and affecting numerous families;

WHEREAS, the Sangguniang Panlungsod of Mandaluyong previously approved a Resolution No. 3719, S-2025 entitled: A RESOLUTION AUTHORIZING THE CITY OF MANDALUYONG, THROUGH THE LOCAL CHIEF EXECUTIVE, HONORABLE CITY MAYOR CARMELITA A. ABALOS, TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON DECEMBER 12, 2025 AT FT. EVANGELISTA, R. PASCUAL & C. FERNANDO STREET, BARANGAY PLEASANT HILLS, MANDALUYONG CITY;

WHEREAS, subsequent validation conducted by the City Social Welfare and Development Department revealed that an additional Ninety-One (91) families were affected by the same fire incident but were not included in the initial list of beneficiaries;

WHEREAS, it is the thrust of the City Government of Mandaluyong to provide sincere and efficient public service to its constituents, especially in times of crisis and emergencies, thus, deeming necessary to extend financial assistance to the affected families and individuals;

WHEREAS, in order to provide equitable assistance, the City Mayor has recommended to grant financial assistance to the additional validated fire victims family amounting to Fifteen Thousand Pesos (P15,000.00) per house owner (28 house owners) and Eight Thousand Pesos (P8,000.00) per house sharer (63 sharers). The total amount of Nine Hundred Twenty Four Thousand Pesos (P924,000.00) financial assistance shall be chargeable against the Calamity Fund or Quick Response Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF), subject to accounting and COA auditing laws, rules and regulations;


WHEREAS, said grant of financial assistance to those affected fire victims merits the consideration of the Sangguniang Panlungsod of Mandaluyong in accordance with the mandated duty of the City to help and promote the welfare of its constituents.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City of Mandaluyong, through the Local Chief Executive, Honorable City Mayor Carmelita A. Abalos, to grant financial assistance to the additional victims of fire that occurred on December 12, 2025 at FT. Evangelista, R. Pascual & C. Fernando Street, Barangay Pleasant Hills, Mandaluyong City.

RESOLVED, FINALLY, that a copy of this Resolution be furnished the Honorable City Mayor CARMELITA A. ABALOS at the Office of the City Mayor, and the respective Mandaluyong City Disaster Risk Reduction and Management Department (MCDRRMD) and City Social Welfare and Development Department, for their immediate information and appropriate action.

ADOPTED on this 19th day of January 2026, in the City of Mandaluyong.






