



RESOLUTION NO. 3733, S-2026

**A RESOLUTION ADOPTING AND
APPROVING THE MANDALUYONG CITY
LOCAL DEVELOPMENT INVESTMENT
PROGRAM 2026-2028**

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) provides that all local government units, as political subdivisions of state, shall have genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. It mandates all Local Government Units (LGUs) to promote the general welfare, generate revenues and manage their own resources, growth and development;

WHEREAS, consistent with the mandate, the City of Mandaluyong through the City Planning and Development Department, has prepared the Local Development Investment Program (LDIP) for fiscal years 2026-2028, grounded on updated research, fiscal data and management, departmental submissions and priority development needs of the City more specifically in the infrastructure and the delivery of basic public services including health services and the preparation of the City to a friendly-city towards business and environmentally-friendly to its constituents;

WHEREAS, the LDIP integrates the programs, projects and activities (PPAs) of all departments and offices of the city government, aligning them with the city's medium-term development goals, public service requirement and infrastructure priorities;

WHEREAS, the City Planning and Development Department has judiciously reviewed, consolidated and strictly scrutinized the preparation of the Local Development Investment Program (LDIP) and has detailed for the appreciation of the Sangguniang Panlungsod the following:

1. Program/Project Activity (PPAs);
2. Brief Description and Implementation Time Frame;
3. Intended Beneficiaries;
4. Lead Office/Implementing Unit;
5. Success and Performance Indicators;
6. Target Areas;
7. Financial Targets and Requirements;
8. Source of Funds;
9. Climate Change PPA- Responsive PPA

WHEREAS, the City Planning and Development Department has prepared the 2026–2028 Local Development Investment Program (LDIP) which embodies programs, projects and activities (PPAs) submitted by the different departments and offices to be implemented by the City Government for the next three (3) years;

WHEREAS, the LDIP for Fiscal Years 2026-2028 reflects the City Government's strategic direction toward enhanced public service delivery, improved fiscal management, resilient infrastructures, inclusive community development and sustainable growth consistent with national and local development frameworks;

WHEREAS, after thorough evaluation and deliberation, the Sangguniang Panlungsod finds the LDIP comprehensive, realistic, and responsive to the current and emerging needs of the City, and recognizes its importance in sustaining Mandaluyong's reputation as a dynamic, innovative, business-friendly, and people-centered City;

WHEREAS, as per evaluation and assessment of the Sangguniang Panlungsod of the Local Development Investment Program (LDIP) of the City for the period 2026-2028, it is a product of a sustained tenacity and shows the basic duties and responsibilities of each department in the growth of the City. This merits the consideration of the Sangguniang Panlungsod of Mandaluyong, in essence, as it will totally enhance the development of our City to a more credible and proactive City.

NOW, THEREFORE, the Sangguniang Panlungsod of Mandaluyong, in session assembled and on motion duly seconded, RESOLVED, as it hereby RESOLVES, to adopt and approve the Mandaluyong City Local Development Investment Program (LDIP) 2026-2028.

ADOPTED on this 26th day of January 2026, in the City of Mandaluyong.


