**RESOLUTION ADOPTING AND APPROVING THE
CAPACITY DEVELOPMENT (CAPDEV) AGENDA
OF THE CITY GOVERNMENT OF
MANDALUYONG FOR THE PERIOD 2026-2028**

WHEREAS, the City Government of Mandaluyong conducted training and workshop for the formulation of the Capacity Development (CAPDEV) Agenda in collaboration with the Department of the Interior & Local Government (DILG) and attended by all Department Heads, Sangguniang Panlungsod members and no less than the Honorable City Mayor Carmelita A. Abalos;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units (LGUs) to ensure the efficient and effective delivery of basic services and facilities to their constituents.

WHEREAS, the Department of the Interior and Local Government (DILG) encourages LGUs to formulate a Capacity Development (CapDev) Agenda to identify and address the gaps in institutional and individual competencies within the local government;

WHEREAS, the City Government of Mandaluyong recognizes the need for a strategic and systematic approach to human resource development and institutional strengthening to meet the evolving challenges of urban governance;

WHEREAS, the City of Mandaluyong has undergone a rigorous process of assessment and planning to produce a CapDev Agenda that aligns with the City's Comprehensive Development Plan (CDP);

WHEREAS, the proposed CapDev Agenda outlines priority programs, projects, and activities designed to enhance the professional skills of City employees, improve organizational systems, and foster a culture of excellence in public service;




